I,______, the undersigned have read and understand, and freely and voluntarily enter into this Release and Hold Harmless Agreement with Weston Valley Ranch LLC dba Weston Equestrian LLC. (Company), understanding that this Release and Hold Harmless Agreement is a waiver of any and all liability(ies).

I am aware of the risks and hazards inherent in entering on the premises or in participating in any activities on or around horses, including risks associated with mounting, riding, walking, boarding, and feeding horses, and elect to voluntarily enter on the premises, knowing its present condition and knowing that its condition may become more hazardous and dangerous during the time that I am on the premises. I expressly assume such risk and hereby agree to waive, release, discharge, indemnify and hold harmless Company, its agents, managers, members, officers, partners, servants, assignees, subsidiaries, and employees of and from any and all liability, claims, demands, actions and causes of action whatsoever, arising out of or related to any loss, damage, or injury, including death, that may be sustained by any or each of the undersigned while in or on these premises, even though that liability may arise out of negligence or carelessness on the part of persons or entities mentioned above. I agree to accept all responsibility for the risks, conditions and hazards which may occur whether or not they are now known.

I recognize and agree that I know which equine professional(s) I will be working with, and acknowledge that I agree said equine professional(s) has/ have made reasonable and prudent efforts to determine my ability to engage in the equine activity, and has/have sufficient knowledge of my equine and horseback riding skills. Therefore, I hereby agree to waive and release, any equine professional(s) I elect to work with from any duty to monitor my equine activities.

I further, hereby agree to waive, release, discharge, indemnify and hold harmless, this (these) equine professional(s) from any liability whatsoever, including, but not limited to, any incident caused by or related to said equine professional's (s') negligence, relating to injuries known, unknown, or otherwise not herein disclosed; including, but not limited to, injuries, death or property damage from: mounting; riding; dismounting; walking; grooming; feeding; use of horse barn, paddock, trails or horse ring, in any capacity; falling off horse whether horse is bucking, flipping, spooked; or my failure to understand any equine professional's directions relating to my riding or otherwise use and control, or lack thereof, of my horse or the horse I have been assigned to.

I hereby agree to waive, release, discharge, indemnify and hold harmless Company, its agents, managers, members, officers, partners, servants, assignees, subsidiaries, and employees from any and all liability, claims, demands, actions, and causes of action whatsoever, arising out of or related to any illness, accidental injury, disability or death suffered by an animal who is boarded in or on the premises of Company.

WARNING- Under Colorado Law, an equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risk of equine activities, pursuant to section 13-21-119, Colorado Revised Statutes.
